**SCHEDULE W01**  
**¾" METERED SERVICE**

**AVAILABILITY:**

Service under this schedule is available for ¾" metered water service and is subject to the District's Service Rules and Regulations. This schedule and the Service Rules and Regulations are subject to change from time to time.

**MONTHLY RATE:**

Basic Facilities Charge:	\$20.00
Water Usage Charge (per 1000 gallons)	\$4.80

**MINIMUM MONTHLY CHARGE:**

The minimum monthly charge under this schedule will be \$20.00 for ¾" metered water service, unless specified otherwise in a service agreement between the District and the customer.

**TERMS OF PAYMENT:**

Bills are due when rendered and are payable within 25 days. If the bill is not paid within the 25-day period, the right to suspend service is retained in accordance with the District's Service Rules and Regulations.

**SCHEDULE W02  
1" METERED SERVICE**

**AVAILABILITY:**

Service under this schedule is available for 1" metered water service and is subject to the District's Service Rules and Regulations. This schedule and the Service Rules and Regulations are subject to change from time to time.

**MONTHLY RATE:**

Basic Facilities Charge:	\$37.00
Water Usage Charge (per 1000 gallons)	\$5.45

**MINIMUM MONTHLY CHARGE:**

The minimum monthly charge under this schedule will be \$37.00 for 1" metered water service, unless specified otherwise in a service agreement between the District and the customer.

**TERMS OF PAYMENT:**

Bills are due when rendered and are payable within 25 days. If the bill is not paid within the 25-day period, the right to suspend service is retained in accordance with the District's Service Rules and Regulations.

**SCHEDULE W03**  
**1 1/2" METERED SERVICE**

**AVAILABILITY:**

Service under this schedule is available for 1 1/2" metered water service and is subject to the District's Service Rules and Regulations. This schedule and the Service Rules and Regulations are subject to change from time to time.

**MONTHLY RATE:**

Basic Facilities Charge:	\$56.25
Water Usage Charge (per 1000 gallons)	\$5.45

**MINIMUM MONTHLY CHARGE:**

The minimum monthly charge under this schedule will be \$56.25 for 1 1/2" metered water service, unless specified otherwise in a service agreement between the District and the customer.

**TERMS OF PAYMENT:**

Bills are due when rendered and are payable within 25 days. If the bill is not paid within the 25-day period, the right to suspend service is retained in accordance with the District's Service Rules and Regulations.

**SCHEDULE W05**  
**2" METERED SERVICE**

**AVAILABILITY:**

Service under this schedule is available for 2" metered water service and is subject to the District's Service Rules and Regulations. This schedule and the Service Rules and Regulations are subject to change from time to time.

**MONTHLY RATE:**

Basic Facilities Charge:	\$72.50
Water Usage Charge (per 1000 gallons)	\$5.45

**MINIMUM MONTHLY CHARGE:**

The minimum monthly charge under this schedule will be \$72.50 for 2" metered water service, unless specified otherwise in a service agreement between the District and the customer.

**TERMS OF PAYMENT:**

Bills are due when rendered and are payable within 25 days. If the bill is not paid within the 25-day period, the right to suspend service is retained in accordance with the District's Service Rules and Regulations.

**SCHEDULE W04  
4" METERED SERVICE**

**AVAILABILITY:**

Service under this schedule is available for 4" metered water service and is subject to the District's Service Rules and Regulations. This schedule and the Service Rules and Regulations are subject to change from time to time.

**MONTHLY RATE:**

Basic Facilities Charge:	\$158.00
Water Usage Charge (per 1000 gallons)	\$5.45

**MINIMUM MONTHLY CHARGE:**

The minimum monthly charge under this schedule will be \$158.00 for 4" metered water service, unless specified otherwise in a service agreement between the District and the customer.

**TERMS OF PAYMENT:**

Bills are due when rendered and are payable within 25 days. If the bill is not paid within the 25-day period, the right to suspend service is retained in accordance with the District's Service Rules and Regulations.
